MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF OLNEY, TEXAS

The City Council of the City of Olney, Texas, met Monday, November 9, 2020, at 6:00 P.M. Those present were: Mayor Phil Jeske, Mayor Pro-Tem Rue Rogers, Councilmembers Tommy Kimbro, Chuck Stennett, Harrison Wellman, and Terri Wipperman. Absent: None. Staff Present: City Administrator Neal Welch, City Secretary Tim Houston, Chief of Police Dan Birbeck, City Clerk Arpegea Pagsuberon, Public Works Director KC Blassingame, Officer Dustin Hudson, Officer William Achey, Officer Joe Logan, and City Attorney William Myers. All agenda items were subject to action. Meeting was broadcast and recorded online using GoToMeeting.com in accordance with Open Meetings Laws guidance during COVID-19 Pandemic Disaster.

Mayor Jeske called the meeting to order at 6:04 P.M.

CALL TO ORDER

Mr. Myers gave the invocation.

INVOCATION

Oscar R. Munoz appeared before Council to thank them for allowing him to exercise his constitutional rights and his rights under the laws of Texas in having the Local Option Election on November 3, 2020.

CITIZEN COMMENT PERIOD

Mayor Jeske entertained a motion to adopt the minutes from the October 26, 2020 Regular Meeting as written. Mayor Pro-Tem Rogers made said motion, and Councilmember Wipperman seconded. Council voted unanimously to approve the minutes.

CONSIDER APPROVAL OF MINUTES FROM PREVIOUS MEETING(S)

Mr. Houston read the following into the record. I, Tim Houston, City Secretary for the City of Olney, Texas, do hereby certify that the following vote totals cast in the November 3, 2020 General and Special Elections are true and correct.

CANVASS ELECTION RESULTS AND SIGN CERTIFICATES OF ELECTION

For Mayor:

Rue Rogers - 1058 votes, none opposed.

For Councilmember: Harrison Wellman – 382 votes Tom Parker – 484 votes Andrew L. McPhie – 180 votes Terri Wipperman – 462 votes

Proposition A: The legal sale of all alcoholic beverages including mixed beverages. For – 728 votes
Against – 442 votes

Mayor Jeske entertained a motion to certify and accept the results of the election as reported by Mr. Houston. Councilmember Stennett made said motion and Councilmember Kimbro seconded. Council voted unanimously to pass the motion.

Mayor Jeske signed the certificates of Election for Rue Rogers, Tom Parker, and Terri Wipperman.

Mayor Pro-Tem Rogers tendered his resignation, to be effective immediately, as a Councilmember and Mayor Pro-Tem.

OATHS OF OFFICE FOR NEWLY ELECTED OFFICEHOLDERS

Mr. Myers swore in Rue Rogers as Mayor of the City of Olney. Mr. Myers swore in Tom Parker and Terri Wipperman as Councilmembers for the City of Olney. Each signed their oath of office and statement of officeholder. Each were seated to the respective positions. Harrison Wellman and Phil Jeske became observers to the meeting.

Present and seated at the meeting: Mayor Rue Rogers, Councilmembers Tommy Kimbro, Tom Parker, Chuck Stennett, and Terri Wipperman.

Mayor Rogers presented former Mayor Jeske with a gavel plaque for twenty-plus years of service to the City of Olney in the position of Mayor and Councilmember.

PRESENTATION TO **OUTGOING MAYOR PHIL** JESKE II

Councilmember Wipperman made a motion to accept the resignation of Rue Rogers from the City Council, and Councilmember Kimbro seconded. Council voted unanimously to accept the resignation.

CONSIDER NOMINATIONS TO FILL UNEXPIRED TERM ON CITY COUNCIL

Mayor Rogers inquired as the to process to fill a vacancy and Mr. Myers explained that under section 4.08 the Council has the authority to fill a vacancy once in a twelve-month period. Mr. Houston read into the record the following: I, Tim Houston, City Secretary for the City of Olney, do hereby certify that the Mayor and City Council of the City of Olney have not made a vacancy appointment to the position of mayor or councilmember in the preceding twelve-month period: Further, I certify that the last such appointment occurred on May 23, 2016, with the appointment of Jeff McClatchy to the vacant unexpired term of Councilmember Chris Garcia.

Mayor Rogers asked Council for nominations to the vacant position. Councilmember Wipperman nominated Harrison Wellman. Councilmember Parker nominated Phil Jeske II. Mayor Rogers sought a second on each nominee. Councilmember Kimbro seconded the nomination of Harrison Wellman. Councilmember Stennett seconded the nomination of Phil Jeske II. Mr. Myers informed Mayor Rogers that he could cast a tie-breaking vote or abstain. Mayor Rogers considered his options and Council discussed both nominees. After consideration, Mayor Rogers voted for Mr. Jeske to fill the Councilmember position.

Mr. Myers swore in Phil Jeske II as a Councilmember of the City of Olney. Mayor Rogers signed his certificate, and Mr. Jeske signed his oath of office and statement of officer.

Present and seated at the meeting: Mayor Rogers, Councilmembers Phil Jeske II, Tommy Kimbro, Tom Parker, and Terri Wipperman.

Mayor Rogers sought nominations for the position of Mayor Pro-Tem. Councilmember Stennett ELECTION OF MAYOR nominated Tom Parker, and Councilmember Kimbro seconded. Councilmember Jeske moved that nominations cease, and Councilmember Kimbro seconded. Council voted unanimously to cease nominations. Council then voted unanimously to elect Tom Parker as Mayor Pro-Tem. (Note: Councilmember Parker referred to as Mayor Pro-Tem Parker from this point forward.)

PRO-TEM

Brian O'Neill, Thelma Box, and Chris Cha from Pacheco Koch were present to discuss their credentials and experience with the Council. Mr. O'Neill gave an overview of their experience. Mrs. Box explain water plant operations and their different options for plants and their experience with both regular water plants and package plants. Mr. Cha discussed funding sources like DWSRF and SWIFT. Discussion ensued about their overall load of projects, which Mr. O'Neill spoke that they did not overload their staff and had approximately a handful of projects active with the team present.

INTERVIEW **ENGINEERING FIRM** CONCERNING WATER TREATMENT PLANT **PROJECT**

Mayor Pro-Tem Parker asked if there were notations of changes. Mr. Welch stated that the manual was completely changed from the old, but that the new parts of policy were primarily in red. Mrs. Pagsuberon explained the text highlighted in red. Mayor Pro-Tem Parker stated he would like the chance to explore both manuals. Mayor Rogers agreed and the item was tabled.

CONSIDER ORDINANCE ADOPTING PERSONNEL POLICIES AND PROCEDURES MANUAL

Council briefly discussed possibly cancelling the meeting due to the proximity to the Thanksgiving holiday. No action was taken.

CONSIDER CANCELLING OR RESCHEDULING COUNCIL MEETING ON NOVEMBER 23, 2020

Mr. Houston gave the monthly financial report. Chief Birbeck gave a report on the police department. Mayor Pro-Tem Parker stated that the police vehicle budget was much improved over years past.

Mayor Rogers stated that Council would enter executive session at 7:41 P.M. to discuss the annual evaluation of City Secretary Tim Houston, pursuant to Section 551.074(a) of the Texas Government Code.
